Cosco receives ASEAN Corporate Governance Scorecard Award

Manila, Philippines - Cosco has recently received a Golden Arrow Award in the recently conducted ASEAN Corporate Governance Scorecard (ACGS) Award for 2022 by the Institute of Corporate Directors (ICD).

ICD's ACGS Award assesses company performance in five categories: promoting shareholder rights, how companies treat their stakeholders, transparency and disclosure, how their board strategically steers their company, and the responsibility of their boards.
