Press Release entitled “COSCO signs Joint Venture Agreement with Siam Global House Public Company”

Cosco Capital, Inc. has approved and signed on June 17, 2022, a Joint Venture Agreement with Siam Global House Public Company Limited to operate a one-stop warehouse for building and construction-related materials, home and garden decorative goods, home improvement goods, construction equipment, and tools.

The signing of Joint Venture Agreement took place at the head office of Siam Global House in Roi Et, Thailand.

The new Joint Venture company will be setup as 55% for Siam Global House Public Company Limited and 45% by Cosco Capital Inc. The initial capital for the new company would amount to Php 500 million.

The Joint Venture is looking to finalize, construct and open 3 to 5 stores in the next 12 to 18 months in the National Capital Region, CALABARZON and Region 3. Siam Global House Public Company Limited is based in Thailand, with 76 stores selling building materials and home decorative products.
